

**Carlson Wagonlit Travel Transat Win Your Trip Back Contest –
OFFICIAL CONTEST RULES**

This “**Carlson Wagonlit Travel Transat Win Your Trip Back Contest**” (the “**Contest**”) is sponsored by Carlson Wagonlit Canada a partnership of CW Travel Canada, Ltd. and 152812 Canada Inc. (“**CWT**”) and by Transat Tours Canada Inc. (“**Transat**”). THIS CONTEST IS INTENDED TO BE CONDUCTED IN ONTARIO, MANITOBA, ALBERTA AND BRITISH COLUMBIA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE “**Contest Rules**”).

1. **Contest Period.** The Contest will run from **Thursday, February 1, 2018 at 12:00 noon Eastern Standard Time (EST) to Wednesday, February 28, 2018 at 11:59 p.m. EST** (the “**Contest Period**”) in Ontario, Manitoba, Alberta and British Columbia only after which time the Contest will be closed and no further entries shall be accepted.
2. **How to Enter:** No purchase necessary to enter or win. This Contest may be entered in one of the following two (2) ways. No other entries will be accepted by any other means:
 - a) By booking (during the Contest Period) a Transat vacation package, tour or cruise through CWT by February 28, 2018 with travel completed by April 30, 2018. Such bookings must be made with CWT over the phone, in store or via www.cwtvacations.ca.
 - b) By a contestant mailing his or her name, with full home address, telephone number, email along with a statement of consent indicating that he or she has read and agreed to the full terms and conditions of the Contest found on www.cwtvacations.ca, to Carlson Wagonlit Travel, **Transat Win Your Trip Back Contest**, 2425 Matheson Blvd East, Suite 600, Mississauga, ON L4W 5K4.

Only one (1) entry per person (by either of the above means) during the Contest Period.

Contest End Date: Entries must be received no later than the end of the Contest Period (February 28, 2018 at 11:59 p.m. EST), or if mailed, then postmarked, no later than February 28, 2018 and received no later than March 5, 2018.

Entries will be declared invalid if they are lost, late, illegible, misdirected, incomplete, damaged, destroyed, delayed, irregular, mutilated, tampered with, altered, fraudulent, forged, garbled or mechanically or electronically reproduced and no responsibility is assumed by CWT for any such entries. If there is a dispute as to the identity of a winner based on an e-mail address, the winning entry will be deemed to be made by the authorized account holder of the e-mail address at time of entry. The "authorized account holder" is the natural person who is assigned an e-mail address by an internet service provider or other organization responsible for assigning e-mail addresses for the domain associated with the e-mail address in question. Any selected entrant may be required to provide CWT with proof that the selected entrant is the authorized account holder of the e-mail address associated with the winning entry.

3. **Eligibility:** This Contest is open only to legal residents of British Columbia, Alberta, Manitoba and Ontario who have reached or surpassed the age of majority in their province of residence as of the first day of the Contest Period, and who are residing such province throughout the Contest Period. This Contest is void in whole or part where prohibited by law.

The Contest is not open to (i) employees of CWT or Transat or their respective affiliated companies, CWT's or Transat's respective agents, advertising agencies, contractors, or other representatives or members of their respective immediate families or those with whom the forgoing persons are domiciled, or (ii) any person who has won a prize from CWT during the period from February 1, 2017 to the start of the Contest Period. CWT shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest.

Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to CWT for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. CWT reserves the right, in its sole discretion, to disqualify any person who supplies untruthful, incomplete, inaccurate or misleading personal details and/or information at anytime.

4. **Winner Selection:**

- a. A draw will be held, to determine a winner (provided the selected entrant complies with these Contest Rules). The draw will be held on Tuesday March 6, 2018 at 1:00 p.m. E.S.T, from all eligible entries received on or before the date described under the heading "Contest End Date" above. The draw will occur at CWT's Mississauga office at 2425 Matheson Blvd. East, Suite 600, Mississauga, ON, L4W 5K4. Subject to any delays as a result of ineligible entries, a contestant's inability to answer a skill testing question or return the Release, the winner will be announced 15 days after the draw, on CWT's Facebook page:

- b. The odds of being selected as the potential winner are dependent upon the number of eligible entries received by CWT at the time of the draw. Before being declared winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question, to comply with the Contest Rules. CWT may, in its sole discretion, provide an alternate skill-testing question or vary the requirements to perform any skill-testing component of the Contest to accommodate and include the participation of entrants with physical or cognitive disabilities.
- c. To be declared a winner and claim the corresponding prize, the selected entrant for the prize must: (i) be reached by phone or e-mail and or/or respond to any phone call, voicemail or e-mail (in each case left at the phone number or email address provided by the selected entrant when submitting his or her entry) within 2 business days of receipt (for this purpose voicemail and e-mail are deemed received on the date left or delivered); (ii) have complied with the official Contest Rules; and (iii) sign and return the Release, described in section 7 of these Contest Rules and correctly answer the skill testing question on that Release, within 5 business days of receipt. Upon satisfaction of the above conditions, the prize letter explaining how, when and where to redeem the prize will be mailed or emailed by CWT to the winner within 30 days of being selected, at the address indicated on the winner's entry form or at the address provided at the time of booking a trip (as applicable depending on the method of Contest entry). If the selected entrant cannot be contacted by e-mail or telephone, fails to return the Contest documents within the specified time, or otherwise does not satisfy any of the above conditions; then he/she will forfeit his/her prize and an alternate winner will be selected. CWT is not responsible for the failure for any reason whatsoever of the winner to receive notification or for CWT to receive a selected entrant's response.

5. **Prize:** There will be one winner drawn at the end of this Contest and only one prize awarded.

The prize, having a total maximum value of up to \$3,000.00 CAD, is described in more detail in section 6 below.

CWT reserves the right to substitute the prize or any component of it (including the destination of the prize and the gateway) for one of equal or greater value.

The prize must be accepted as awarded and is not transferable or convertible to cash or to another person's name. No substitutions except at CWT's option. CWT reserves the right to substitute the prize for one of equal or greater value. CWT shall not assume any liability for a lost, damaged or misdirected prize. Only the winner will be notified and CWT will not communicate to individuals the fact that they have not won this Contest. Upon written request to CWT delivered to Carlson Wagonlit Travel, 2425 Matheson Blvd East, Suite 600, Mississauga, ON L4W 5K4, Attention: Marketing Manager, the winner of the prize will be disclosed.

6. **Prize Description:** The prize consists of one of the following:

1) Either the reimbursement of the value of a Transat vacation package, tour or cruise (taxes and service fees are not included) booked through CWT by February 28, 2018 with travel completed by April 30, 2018, up to a maximum reimbursement of \$3,000.00 CAD; or

2) A travel credit for a Transat vacation package, tour or cruise (to be booked through CWT), valued at \$3,000.00 CAD.

No modifications will be possible once the booking has been made. The Travel Voucher must be used within 180 days of being awarded and certain conditions may apply to its use as set out in the prize letter. Once the trip is confirmed, no changes can be made to the date of travel or the names of the passengers. All bookings are subject to 100% cancellation penalties.

- a. The travel voucher must be used for travel by the winner, or one or more persons including the winner.
- b. The prize is non-transferable, has no cash value for the winner. In the case of a voucher, its expiration date cannot be extended. In the case of a voucher, any travel booked that costs in excess of the value of the voucher must be paid by the winner at the time of booking.
- c. CWT reserves the right to offer a comparable product in the event of a program cancellation, act of God or other unforeseen circumstances.

- d. If you are unable to redeem any or all the prize components due to reason beyond the control of CWT and all parties associated with the prize, then no compensation or substitutions will be provided.
 - e. You agree to have your name and/or photo published for advertising and promotional purposes, as CWT sees fit.
7. **Release**: The prize winner will be required to execute a written release (“**Release**”) that confirms his or her: (i) eligibility for this Contest and compliance with these Contest Rules; (ii) acceptance of the prize as offered; (iii) release of CWT and Transat and their respective parent companies, subsidiaries, affiliates and/or related companies (and their respective successors and assigns) and each of their respective employees, directors, officers, suppliers, agents, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively, the “**Releasees**”) from any and all liability from any manner of actions, causes of action, suits, debts, dues, accounts, bonds, covenants, contracts, claims, loss, harm, damages, cost or expenses which the prize winner ever had, now has or may in the future have against the Releasees for or by reason of any cause, matter or thing arising out of participation in this Contest, participation in any Contest-related activity, any travel taken in connection with any prize won in this Contest, or the acceptance, use, or misuse of the prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom; and (iv) granting to CWT and Transat of the unrestricted right, in their respective discretion, to produce, reproduce, publish, reproduce, convert, broadcast, communicate by telecommunication, exhibit, distribute, translate, the winner’s name, photograph, likeness, voice and biography in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof and consenting to the public disclosure of his or her name as a winner of this Contest. The executed Release must be returned (with the mathematical skill testing question correctly answered), within five (5) business days of the date indicated on the accompanying email letter of notification or the verification as the winner, or he/she will be disqualified and the prize forfeited.
8. **Indemnification by Entrant**: By entering the Contest, each contestant releases and holds the Releasees harmless from any and all liability for any injuries, loss or damage of any kind to him or her or any other person, including personal injury, death, or property damage, resulting in whole or part, directly or indirectly, from such contestant’s acceptance, possession, use or misuse of the prize, participation in the Contest, breach of any of these Contest Rules, or from any prize-related activity undertaken by such contestant. Each contestant shall fully indemnify the Releasees from any and all claims by third parties relating to the Contest.
9. **Online Registration**: CWT will not be responsible for any problem or technical malfunctions or operational problems with any telephone network or lines, computer online systems or servers, computer software problems or traffic congestion on the internet or at any website and assumes no liability for damage to any contestant’s or any other person’s computer resulting from participating in this Contest.

10. **Changes:** If, for any reason, any portion of this Contest is not capable of running as planned or if the administration, security, fairness, integrity, or proper conduct of this Contest is corrupted or adversely affected, including without limitation by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any other causes beyond its control or for any other reason whatsoever, then CWT, in its sole and absolute discretion, may cancel, terminate, modify (including extending or shortening the Contest Period) or suspend the Contest without individual notice. 11. **For all participants**, any litigation must be initiated in the City of Toronto.
12. **Conduct:** By participating in the Contest, each entrant agrees to be bound by the Contest Rules, which will be posted at the www.cwtvacations.ca website throughout the Contest Period and to be bound by the decisions of CWT (which will be final on all matters relating to this Contest). CWT reserves the right, in its sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process, or the operation of the Contest or the CWT Website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any online CWT property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. CAUTION; ANY ATTEMPT TO DELIBERATELY DAMAGE THE CWT CONTEST WEBSITE OR ANY OTHER CWT WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. IF SUCH AN ATTEMPT IS MADE, CWT RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING, BUT NOT LIMITED TO CRIMINAL PROSECUTION.
13. **Privacy/Use of Personal Information:**
- a) By submitting an entry to this website each contestant:
- (i) grants to CWT the right to use his or her name, telephone number, province and city of residence, age, gender, language, email address, photograph (“**Personal information**”) for the purpose of administering this Contest, including but not limited to contacting and announcing the winner (and the prize won) and contacting him or her to confirm any of the information, consents, and grants that he or she has provided;
 - (ii) grants to CWT the right to use his or her contact information to contact him or her regarding any issues, notifications, or corrections arising from or in connection with the Contest, including without limitation relating to any prize awarded,
 - (iii) grants to CWT the right to use his or her Personal information for publicity and promotional purposes including but not limited to those relating to the Contest, in any and all media now known or hereafter devised, developed using the rights granted in connection with the Contest without further compensation unless prohibited by law, and
 - (iv) acknowledges that CWT may disclose his or her Personal information to third-party agents and service providers of CWT (including any outside of Canada), in connection with any of the activities listed in (i) (ii) and (iii) above.

b) All entries become the property of CWT and none will be returned. CWT reserves the right, at its option, to publish the winner's name, address, photograph, likeness, voice or statements at any time without further compensation to the winner.

c) CWT may retain and use the Personal Information described in paragraph 13(a) for future marketing of its products, services and promotions to each contestant and may share the Personal Information with companies with whom CWT has marketing and other promotional arrangements for the purpose of providing each contestant with information about their products and services.
